REGULAR MEETING
March 26, 2018

The President of the Board, Steve Benard called the meeting to order at 7PM in the District Office. Roll call showed the following people present: Steve Benard, Jeff Maze, Michael Cloud, Scott Patterson, Judy Billingsley, Mark Shumake, and Brad Trovillion.

Motion by Brad Trovillion, and seconded by Mark Shumake, the Board voted to accept the consent agenda items including: minutes of the regular meeting, and closed session minutes on February 26, 2018, payroll and district bills, and school district financial reports. Motion by Jeff Maze, and seconded by Michael Cloud, the Board voted to we approve the resignation for retirement of Judy White at the end of the 2017-2018 school year as proposed. On a roll call vote: Benard, Maze, Cloud, Patterson, Billingsley, Shumake, and Trovillion voted yea; no nays and the motion carried.

Motion by Scott Patterson, and seconded by Mark Shumake, the Board voted to employ Johnnie Edwards as Assistant High School Softball Coach as proposed. On a roll call vote: Benard, Maze, Cloud, Patterson, Shumake, and Trovillion voted yea; Billingsley abstained; no nays and the motion carried.
