Motion by Brad Trovillion, and seconded by Mark Shumake, the Board voted to accept the consent agenda items including: minutes of the regular meeting, and closed session minutes on October 22, 2018, payroll and district bills, and school district financial reports. Motion by Scott Patterson, and seconded by Judy Billingsley, the Board voted to tentatively approve Option 2. On a roll call vote: Benard, Maze, Patterson, Billingsley, Shumake, and Trovillion voted yea; no nays and the motion carried.

Motion by Mark Shumake, and seconded by Jeff Maze, the Board voted to approve paying salaries for custodial and maintenance staff through the Operations and Maintenance Fund as proposed. On a roll call vote: Benard, Maze, Patterson, Billingsley, Shumake, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Mark Shumake, the Board voted to approve the Memorandum of Understanding with the Regional Office of Education #21 for alternative school access as proposed. On a roll call vote: Benard, Maze, Patterson, Billingsley, Shumake, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Scott Patterson, the Board voted to approve paying substitute teachers \$82, effective December 1, 2018, as proposed. On a roll call vote: Benard, Maze, Patterson, Billingsley, Shumake, and Trovillion voted yea; no nays and the motion carried.
