

GOREVILLE COMMUNITY UNIT #1
REGULAR MEETING
November 22, 2021

The President of the Board, Steve Benard called the meeting to order at 6PM in the Media Center. Roll call showed the following people present: Steve Benard, Jeff Maze, Michael Cloud, Mark Shumake, Judy Billingsley, Teresa Baker, and Brad Trovillion.

Visitors: None

No one was present to address the Board during Public Hearings and Petitions.

Motion by Michael Cloud, and seconded by Brad Trovillion, the Board voted to accept the consent agenda items including: minutes of the regular meeting, and closed session minutes on October 25, 2021, payroll and district bills, and school district financial reports. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Brad Trovillion, the Board voted to go into closed session at 6:05PM to confidentially discuss information regarding the employment of specific personnel. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Brad Trovillion, the Board voted to reconvene the regular meeting at 6:22PM. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea, no nays and the motion carried.

Motion by Jeff Maze, and seconded by Teresa Baker, the Board voted to go into closed session at 6:26PM to confidentially discuss information regarding the employment of specific personnel. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Mark Shumake, the Board voted to reconvene the regular meeting at 7:43PM. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea, no nays and the motion carried.

Motion by Jeff Maze, and seconded by Michael Cloud, the Board voted to approve increasing Mandy Schuetz's salary \$1 per hour effective October 1 for the additional reporting duties and increasing Christi King's Principal salary by \$5,000 annually to call subs (for the extra time outside of school) and amending her job description to include securing and maintaining all substitutes (both certified and non-certified) for the entire district. On a roll call vote: Benard, Maze, Cloud, Shumake, and Billingsley, voted yea; Teresa Baker and Brad Trovillion voted nay and the motion carried.

Motion by Jeff Maze, and seconded by Brad Trovillion, the Board voted to accept the resignation of Will Stanley as at-will Individual Aide effective November 17, 2021. On a roll call vote:

Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Judy Billingsley, and seconded by Teresa Baker, the Board voted to employ Hunter Kilmer as an at-will Individual Aide. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Judy Billingsley, the Board voted to employ Anna Craig and Samantha Sweitzer as Co-Freshman Class Sponsors. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Michael Cloud, and seconded by Judy Billingsley, the Board voted to employ Jeff Jones as 5th/6th Grade Boys Basketball Coach. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Jeff Maze, the Board voted to reschedule the regular December Board Meeting to Monday, December 20, 2021 at 6 PM. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Jeff Maze, the Board voted to tentatively approve Option 1 of the tentative Tax Levy. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Mark Shumake, and seconded by Michael Cloud, the Board voted to approve paying salaries for custodial and maintenance staff through the Operations and Maintenance Fund as proposed. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Brad Trovillion, the Board voted to approve the tentative policies as proposed. On a roll call vote: Benard, Maze, Cloud, Shumake, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.
