REGULAR MEETING  
October 24, 2022

The President of the Board, Steve Benard called the meeting to order at 6PM in the District Office. Roll call showed the following people present: Steve Benard, Jeff Maze, Michael Cloud, Judy Billingsley, Teresa Baker, and Brad Trovillion.

No one was present to address the Board during Public Hearings and Petitions.

Motion by Brad Trovillion, and seconded by Jeff Maze, the Board voted to accept the consent agenda items including: minutes of the regular meeting, and closed session minutes on September 26, 2022, payroll and district bills, and school district financial reports. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Brad Trovillion, the Board voted to go into closed session at 6:02PM to confidentially discuss information regarding the employment of specific personnel. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Judy Billingsley, the Board voted to reconvene the regular meeting at 6:18PM. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea, no nays and the motion carried.

Motion by Teresa Baker, and seconded by Brad Trovillion, the Board voted to employ Gunnar Halstead as part-time (5 hour) 180-day (prorated to the end of the school year) custodian as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Teresa Baker, and seconded by Brad Trovillion, the Board voted to accept the resignation of Johnie Edwards as Assistant High School Girls Softball Coach as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Michael Cloud, the Board voted to employ Bryan Webb as Assistant High School Girls Softball Coach as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker voted yea; Brad Trovillion abstained and motion carried.

Motion by Michael Cloud, and seconded by Brad Trovillion, the Board voted to accept the resignation of Brian Taylor as Boys Freshman/Sophomore Basketball Coach and approve him as a volunteer basketball coach as proposed. On a roll call vote: Benard,

Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Judy Billingsley, and seconded by Michael Cloud, the Board voted to employ Mike Qualls as Boys Freshman/Sophomore Basketball Coach as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Teresa Baker, and seconded by Judy Billingsley, the Board voted to employ Jordan Suits and Madison Kramp as Freshman Class Co-Sponsors as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Judy Billingsley, and seconded by Michael Cloud, the Board voted to employ Alexis Massey as Junior High Volleyball Assistant Coach as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Brad Trovillion, and seconded by Judy Billingsley, the Board voted to approve the updated Risk Care Management Program as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Jeff Maze, and seconded by Judy Billingsley, the Board voted to approve the proposed Tort Resolution as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Judy Billingsley, and seconded by Michael Cloud, the Board voted to approve the Library/Media Guidelines and the grant application as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.

Motion by Judy Billingsley, and seconded by Brad Trovillion, the Board voted to approve the waiver of fees for the rental of the cafeteria for a benefit on November 5 as proposed. On a roll call vote: Benard, Maze, Cloud, Billingsley, Baker, and Trovillion voted yea; no nays and the motion carried.
